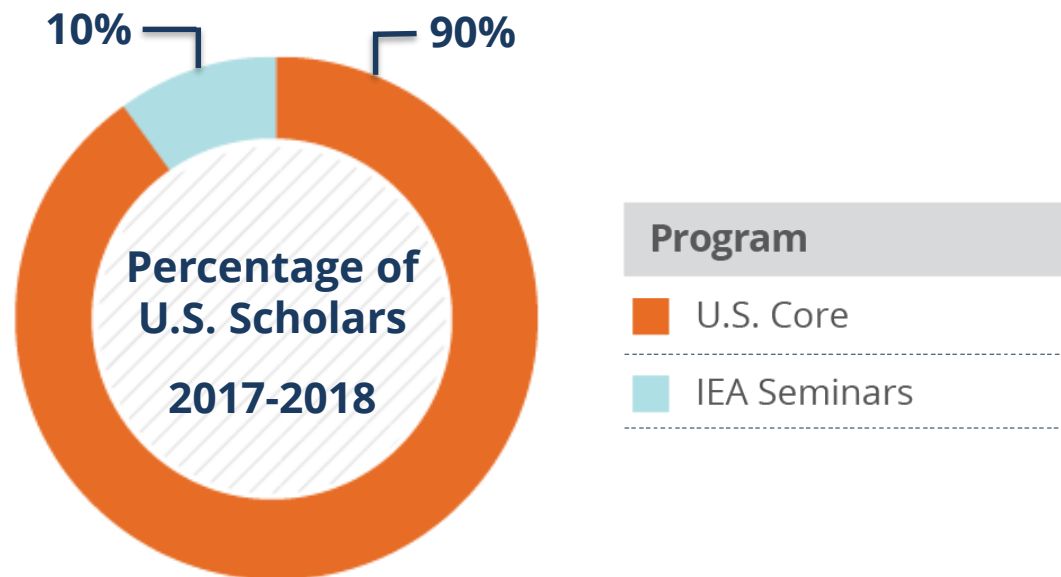

- Appropriate professional experience and accomplishments
- Additional requirements vary by award
- New policies on previous Fulbright Scholar grants and waiting periods between grants

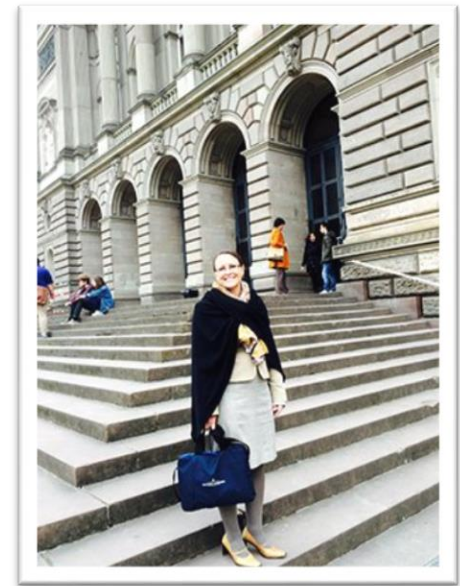

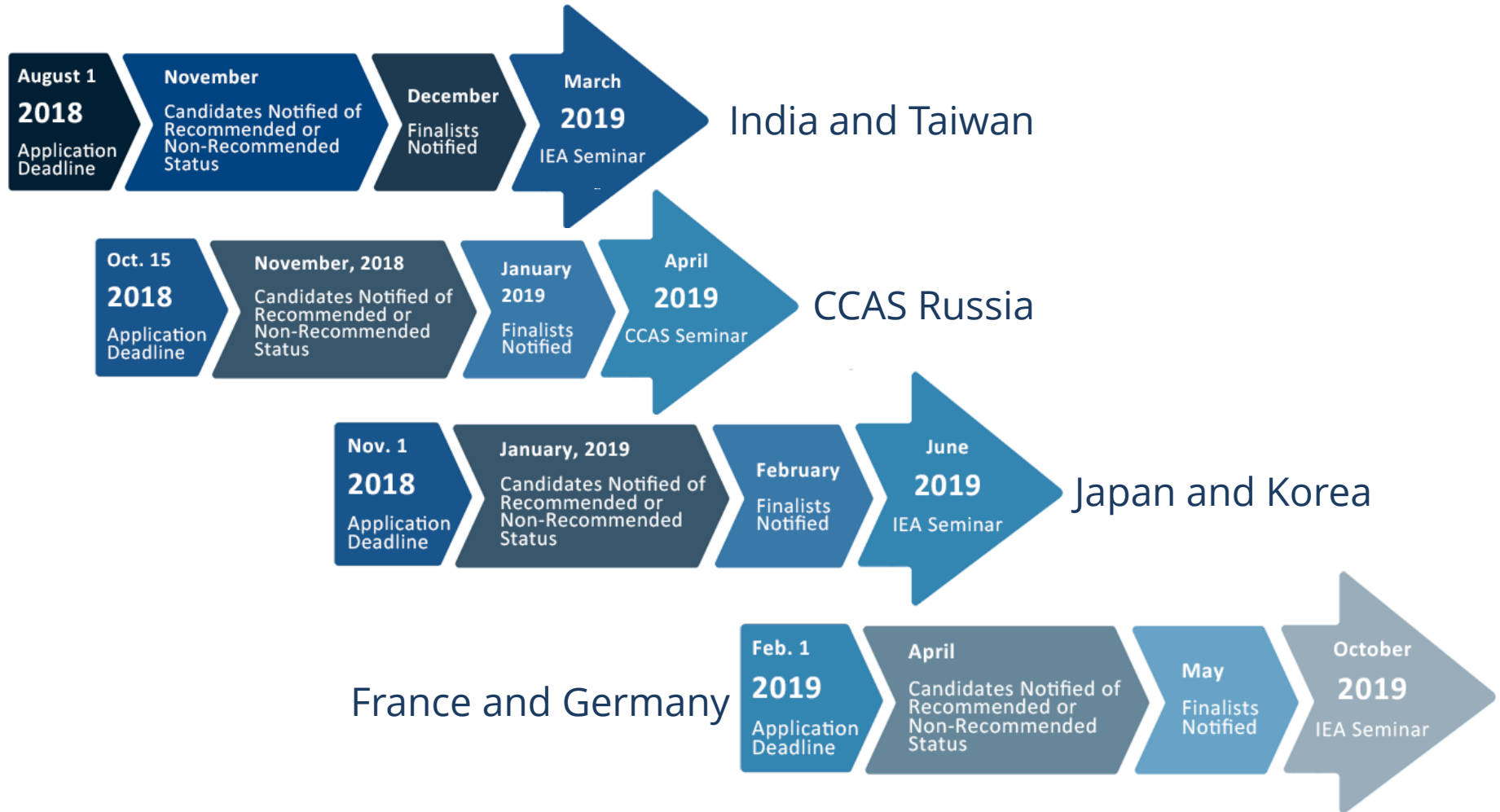
