
## Eligibility for IEA Programs



- U.S. citizenship
- Ph.D. or other terminal degree not required
- Appropriate professional experience and accomplishments
- Additional requirements vary by awards
- New policies on previous Fulbright Scholar grants and waiting periods between grants

## Statement of Intent

- Your current job responsibilities and how they relate to this grant.
- The impact your participation would have on your career, professional development, home institution, and/or community.
- Why you have chosen this country?
- How you would share what you have learned with your home institution and others?
- How the IEA seminar would contribute to the international education goals of your institution?
- Award specific requirements!

## Preparing for the Program

- The Application
- How does this fit within your professional development plan?
- Highlight your leadership role within the college/system
- Know the gaps/needs of your institution (what does internationalization mean?)
- Highlight benefits of the broader community
- Articulate your biases and your research questions
- The Program
- If selected, the timeline is quick; make plans
  - If not selected, try again and refocus (see above)
- Work with team for presentations topics / approaches
- From "Forming to Performing"; how about "Storming and Norming"?
- "Where's my Fitbit?"
- Being a celebrity until your not







## Post-Program Considerations

- Post-Fulbright
- Unlimited possibilities until reality hits; be strategic on college strengths & sustainability
- Russian impressions of Community Colleges; Bologna Accord; Political Climate
- General College Presentations and direct faculty / program engagement / recruitment
- Role as a liaison doesn't end
- Example of Success (Amur State U)
- Example of Failure
