- ▶ Appropriate professional experience and accomplishments
- ▶ Additional requirements vary by awards
- ▶ New policies on previous Fulbright Scholar grants and waiting periods between grants

- ▶ Minimum of five years of experience
- ▶ Affiliated with a college, university, community college or non-profit education exchange organization

- ▶ Deadline: February 3, 2020

- ▶ Grant Dates: Mid October 2020
