The Fulbright Scholar Program

Background

- Created in 1946 by U.S. Congress
- A program of the U.S. Department of State.
- In the United States, the Fulbright U.S. Scholar Program is managed by IIE.
- Implemented by bi-national Commissions and U.S. Embassies abroad.
- Supports research, teaching, seminar attendance, and professional projects abroad in 120+ countries

Key Features of the Fulbright U.S. Scholar Program



- 1. Unmatched Scale: With nearly 800 awards granted annually, Fulbright is the largest fellowship program available to U.S. scholars
- **2. A Mission of Connection:** As a flagship public diplomacy initiative, Fulbright is dedicated to fostering long-term international relationships and mutual understanding
- **3. Broad Range of Opportunities:** With more than 380 unique awards, the program offers options to suit nearly every academic discipline, methodology, institution type, and career stage

Qualifications for U.S. Scholar IEA Awards

- > U.S. citizenship
- > Degree and experience, as required by award:
 - > Ph.D. or other terminal degree not required
 - ➤ 3 5 Years of professional experience within the field of international education
 - Working full-time at a U.S. higher ed institution or international exchange organization
- ➤ Fulbright IEA alums are eligible: Recipients of a Fulbright IEA award are eligible to apply for another Fulbright IEA seminar two years after the date of completion of the previous grant.

France IEA Award

<u>Senior-level</u> administrators (such as deans, directors, vice presidents, provosts, and presidents) with substantial responsibility for enhancing the international dimension of their institutions;

Minimum of five years of full-time work experience in the field of international education









Germany IEA Award

Professionals working on international exchanges: student or faculty exchanges, foreign student admissions and advising, study abroad programs and international education exchange services.

Administrators who have substantial responsibility for enhancing the international dimension of their institutions and for international program development within the offices of Career Services, Alumni Affairs, Development and Fundraising are encouraged to apply

Applicants are given preference who have at least **three years** of experience in administrative work and supervisory responsibility in any of the above-named areas and who have been **employed in such a position at the current institution for at least one year.**









Fulbright-Nehru India IEA Award

This award is *designed for administrators* who wish to build their institutional capacity to enhance study abroad to 'non-traditional' destinations and expand opportunities for international collaborations through **faculty** and student exchange, **collaborative research projects**, and **pursuit of innovative curricular design**.

• International education administrators (for example, senior international officers, foreign student advisors, study abroad advisors, and foreign student admissions staff)

OR

- Senior-level university administrators (such as deans, vice presidents, provosts, and presidents) in strategic
 positions of decision-making with substantial responsibility for enhancing the international dimension of their
 institutions
- All eligible applicants must have at least five years of related experience, either in the field of international education or serving as a senior level administrator.









IEA Application Components

- Two Letters of Recommendation
- CV or Resume be explicit about your qualifications
- Institutional Statement
 - Type of institution, total enrollment, number of degrees offered, etc.
 - Number of international students on campus and where they are coming from.
 - Study abroad opportunities available on your campus.
 - Institutional partnerships, particularly with universities in the country where the grant takes place.
 - Plans and strategies to build international engagement.









Application Cycle

FEBRUARY	Competition Opens
SEPTEMBER 15	Application Deadline
SEPTEMBER	IIE staff conducts Preliminary Screening
OCTOBER – NOVEMBER	U.S. Peer Review
DECEMBER	Applicants notified of Peer Review result
DECEMBER - JUNE	Final decisions are made by Fulbright Commissions or U.S. Embassies abroad and by the Fulbright Foreign Scholarship Board in the U.S.
JUNE – ONWARD	Participants are selected and prepare for departure
