Question	Answer
The fullbright opportunity is it limited to only US CITIZENS? I am have a PhD in Structural Engineering with over 7 years teaching experience in Nigeria and over 50 published journal articles. What are the opportunities for me in fullbright?	Hello! Yes, as our eligibility requirements state, applicants must have U.S. citizenship. Please reach out to your country's commission or embassy and ask them what opportunities are open to you.
Please how do i contact my country's commission? Do you have an email address or a contact person to communicate with?	You can find that information here: https://exchanges.state.gov/non-us/program/fulbright- visiting-scholar-program.
I am already a Fulbright Specialist (art history) and am hoping to find a project that will be for only 2 weeks. Are there any projects in the humanities for only 2 weeks?	Hello! There are currently no Fulbright U.S. Scholar projects in the humanities that are only 2 weeks.
Do you encourage recently retired scholars? (I am transitioning this fall from Professor to Professor Emeritus)	Hello! The Fulbright Scholar Program welcomes scholars and professionals at all stages of their careers. Retired and emeriti faculty receive awards each year! Be sure to check the description's award requirements section for additional qualifications necessary to apply.
What are the most appropriate and effective strategies for securing a letter of support from a host institution for the application?	Contact the host institution, usually the dean. Have a zoom call to introduce yourself and talk about your research
I applied for a Fulbright award to Ireland in 2014 and was approved on the U.S. side, but not the Irish side. Is it possible to receive feedback from the previous submissions to try and improve application for the future?	Hello! Unfortunately, we are unable provide feedback due to FFSB policy.
Ok, thank you. I'll have to figure out which makes most sense. Are there All Disciplines awards in Ireland for both student and post doc programs?	The student program is a completely different program, with their own awards. The awards shown today are for the scholar program. I was selected as an alternate for the Ireland award this past cycle. I am going to apply for the next cycle. Should I mention this in my application?	Hello! Applications are reviewed individually, on their own merit each year, so your status from (the) prior competition(s) will not be taken into account by the peer reviewers.
If you were chosen as an alternate this year but did not ultimately get chosen, does that count in the 2-year moratorium on applying?	Hello! No, it does not.
I am an American citizen currently teaching outside of the US - does this impact my application since I will not be coming directly from a US institution?	Hello! Please take note that we do have eligibility requirements based on residency abroad. Applicants who have resided abroad for five or more years in the six-year period preceding the application deadline are ineligible. A period of nine months or more during a calendar year constitutes a full year.
If one receives an award for 2025 but other circumstances intervene, can the award be postponed for a year?	Hello! Awards are not able to be deferred.
